- In a case of first impression in New York, obtained summary judgment in N.Y. Supreme Court (and affirmance by Appellate Division, 1st Dept.) on behalf of a prestigious law firm on its claim for trespass against outgoing commercial holdover tenant which had failed to vacate its space after its lease had expired
- Obtained reversal in N.Y. Appellate Division, 1st Dept. on behalf of an internationally acclaimed restaurant whose recently granted liquor license had

been cancelled by a lower court in Article 78 proceeding on the basis that the license was improperly issued by N.Y. State Liquor Authority
