**Art and Museum Law**

Pryor Cashman attorneys have represented artists, museums, foundations, galleries, and purchasers, sellers and consignors of art in a variety of legal matters, including litigation, governance issues involving museums and foundations, estate and tax planning, insurance, licensing and other transactional work.

**Counseling and Transactional Work**

- Negotiating and drafting (on behalf of sellers, purchasers and consignors) licensing and other agreements by which art is transferred (including by sale, consignment and charitable donation)
- Representing artists in estate and tax planning matters

## Litigation

Our litigation attorneys have represented artists, owners and galleries in a wide variety of matters, including claims concerning lost, stolen and forged art, copyright infringement, and the appropriateness of minimum bids in auction house proceedings. At Pryor Cashman, we:

- Have successfully represented through trial, and continue to represent on appeal, the owner of Egon Schiele art against allegations that the art had been expropriated by the Nazis during World War II
- Represent the Dedalus Foundation (established by the Estate of Robert Motherwell) generally in connection with claims relating to works by Motherwell, as well as in corporate and employment matters
- Represent The Jewish Museum as the custodian of art by Camille Pissaro that is the subject of a title dispute in bankruptcy litigation
- Represented Leo Castelli Gallery, Leo Castelli, the Estate of Leo Castelli and The Castelli Gallery in various matters, including insurance disputes, contract and fiduciary duty claims, stolen and missing art claims, lease disputes and intellectual property matters
- Represent numerous collectors who acquired art allegedly by internationally renowned artists, including Pablo Picasso, Alexander Calder, Alberto Giacometti and Willem de Kooning, which pieces were later demonstrated to have been forged
- Represented the galleries of Ileana Sonnabend and Charles Cowles concerning leasehold, ownership and fiduciary duty disputes
